

# CALL FOR EXPRESSION OF INTEREST PROVISION OF SURVEY DATA COLLECTION SERVICES

#### 1. OBJECTIVE

The Human Resource Development Council (HRDC) is hereby seeking Expressions of Interest (EOI) from team of consultants/firms having the necessary capabilities and experience for the provision of **survey data collection services**. The required scope of services consists of the following areas:

Train interview team
Sampling
Conduct and supervise interviews
Quality control
Coding and Data entry

This exercise aims at listing potential individuals/firms who will be invited to participate in a Request For Quotation (RFQ) exercise.

Interested team of consultants/firms must reckon at least 5 years' experience in conducting large scale national surveys and administering questionnaires through face-to-face interviews. For this exercise, members of the team should have a good knowledge of private enterprises in terms of sector, type of activity, size of enterprise and geographical location. The data entry operator should be conversant with the SPSS software.

The HRDC would prefer to retain one team of consultants/firm for all its data collection processes and the team of consultants/firm covering the maximum number of the above services shall have an advantage.
